

BYLAW 1, 1993

A BYLAW TO AMEND THE MEMORANDUM OF AGREEMENT IN BYLAW 1, 1987,  
RESPECTING THE PROVISION FOR FIRE PROTECTION SERVICES.

The Council of the Rural Municipality of Hillsdale No. 440,  
in the Province of Saskatchewan, enacts as follows:-

- 1] That the following properties be added to item 1  
in the Memorandum of Agreement respecting those  
portions of the R. M. of Manitou Lake No. 442:-

Township 46, Range 25, W3M - Sections 25, 26;  
E½ of Section 27;  
South ½ & NW¼ of Sec. 35.

BETWEEN: Rural Municipality of Hillsdale No. 440,  
 Rural Municipality of Manitou Lake No. 442,  
 Village of Neilburg,  
 Neilburg & District Rural Fire Association, Inc

## THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1] The parties to this Agreement agree to jointly provide fire protection services to the residents of the Municipalities party to this Agreement, being all of the Village of Neilburg; that portion of the R. M. of Hillsdale No. 440 described as follows:-

Township 43, Range 25 - Sections 1 to 36 inclusive;  
 Township 44, Range 25 - Sections 1 to 36 inclusive  
 Township 45, Range 25 - Sections 1 to 36 inclusive;  
 Township 43, Range 24 - Sections W $\frac{1}{2}$ 3, 4,5,6,7,8,9,W $\frac{1}{2}$ 10,

W $\frac{1}{2}$ 15, 16,17,18,19,20,21,W $\frac{1}{2}$ 22,  
 W $\frac{1}{2}$ 27, 28,29,30,31,32,33,W $\frac{1}{2}$ 34;

Township 44, Range 24 - Sections W $\frac{1}{2}$ 3, 4,5,6,7,8,9,W $\frac{1}{2}$ 10,  
 W $\frac{1}{2}$ 15, 16,17,18,19,20,21,W $\frac{1}{2}$ 22,  
 W $\frac{1}{2}$ 27, 28,29,30,31,32,33,W $\frac{1}{2}$ 34;

Township 45, Range 24 - Sections 1 to 10 inclusive and  
 S $\frac{1}{2}$ 21, 29,30 and 31;

Township 46, Range 24 - Sections 6, 7 and 18;

and that portion of the R. M. of Manitou Lake No. 442 described as follows:-

Township 46, Range 25, W3rd - Sections 1 to 24 inclusive, exclu  
 S $\frac{1}{2}$  of section 18, and the NE $\frac{1}{4}$  of Sectio

Township 46, Range 26, W3rd - Sections 1,2,3; 9 to 16 inclusive  
 21,22,23,24; the S $\frac{1}{2}$  of Section 25;26,27

Township 46, Range 25, W3rd - Sections 25, 26, East half of 27,  
 South 1/2 & NW 1/4 of 36

- 2] The parties to this Agreement further agree that:-

(a) The Rural Municipalities of Hillsdale No. 440 and Manitou Lake No. 442 agree to jointly collect taxes from the portions of the said Rural Municipalities described above and remit the said taxes to the Neilburg & District Rural Fire Association Inc.

(1) to purchase a 1964 Fargo 500 Truck, s/n 2582929125, with a 425 G.P.M. Front Mount Barton-American Pump and 800 gallon water tank;

(2) to pay one half the capital cost to construct a two bay Fire Hall in conjunction with the Village of Neilburg;

(3) to operate the Fire Truck and pay one half the maintenance on the Fire Hall.

(b) The Neilburg and District Rural Fire Association Inc. is responsible for the operation and to pay for the operational costs of the Fire Truck, including insurance.

(c) The Village of Neilburg and the Neilburg & District Rural Fire Association Inc. agree to jointly provide heated storage for the unit described in item (a)(1) hereof.

(d) The joint Fire Chief and joint Deputy Fire Chief for the Village of Neilburg and the Neilburg & District Rural Fire Association Inc. are responsible for the dispatching of the Fire Truck.

- 3] That the Village of Neilburg have use of the above Fire Truck.
