BYLAW 4/2023

A BYLAW TO REPEAL BYLAWS 3/1975, 2/1989, 4/1989, 1/1993, 2/1995, 7/1997, 1/2003, 12/2016, 4/2014, 2/2015, 3/2015, 4/2015, 1/2017, 2/2017, 5/2017, 1/2018, 6/2018, 5/2019 and 6/2019

The Council of the Rural Municipality of Hillsdale No. 440, in the Province of Saskatchewan, enacts as follows: -

1. Bylaw 3, 1975 being a bylaw for establishing a recreation board, passed December 2, 1975 is hereby repealed.
2. Bylaw 2, 1989 a bylaw concerning the appointment of an agriculture, development and diversification board, passed March 9, 1989 is hereby repealed.
3. Bylaw No. 4, 1989 a bylaw to provide for entering into an agreement for the establishment of a mutual aid area emergency measures organization, passed March 9, 1989 is hereby repealed.
4. Bylaw 1, 1993 being a bylaw to amend the memorandum of agreement in bylaw 1, 1987, respecting the provision for fire protection services, passed June 3, 1993 is hereby repealed.
5. Bylaw 2, 1995 being a bylaw to amend bylaw no. 2, 1978, of the said rural municipality, passed July 6, 1995 is hereby repealed.
6. Bylaw 7, 1997 being a bylaw to establish a harassment policy, passed November 6, 1997 is hereby repealed.
7. Bylaw No. 1/2003 being a bylaw to provide for the exchange of dedicated lands within the hamlet of Carruthers passed April 3, 2003 is hereby repealed.
8. Bylaw 12/2016 being a bylaw to repeal bylaws 12/2006; 4/2007; 2/2010; 8/2016 passed December 8, 2016 is hereby repealed.
9. Bylaw 4/2014 being a bylaw to authorize the expropriation of land passed March 6, 2014 is hereby repealed.
10. Bylaw 2/2015 being a bylaw to provide for the closing and selling of municipal road, passed January 8, 2015 is hereby repealed.
11. Bylaw 3/2015 being a bylaw to provide for the closing and selling of municipal road, passed January 8, 2015 is hereby repealed.
12. Bylaw 4/2015 being a bylaw to provide for the closing and selling of municipal road, passed June 4, 2015 is hereby repealed.
13. Bylaw 1/2017 being a bylaw to provide for the closing and selling of municipal road, passed April 20, 2017 is hereby repealed.
14. Bylaw 2/2017 being a bylaw to provide for the closing and selling of municipal road, passed April 20, 2017 is hereby repealed.
15. Bylaw 5/2017 being a bylaw to provide for the closing of a municipal road, passed August 3, 2017 is hereby repealed.

16. Bylaw 1/2018 being a bylaw to authorize the expropriation of land, passed January 10, 2018 is hereby repealed.
17. Bylaw 6/2018 being a bylaw to authorize the expropriation of land, passed November 8, 2018 is hereby repealed.
18. Bylaw 5/2019 being a bylaw to authorize the expropriation of land, passed October 3, 2019 is hereby repealed.
19. Bylaw 6/2019 being a bylaw to authorize the expropriation of land, passed October 3, 2019 is hereby repealed.
