Schedule 'B' Public Works Report

Most things have been in 'limbo' for month of August, due to holidays, however, crew continued regular maintenance.

163 concrete barricades were installed along water on west side of the slough on Baldwinton Grid.

This is looking to be successful at breaking waves to stop the destruction of pavement.

Various discussions about how to sign the Baldwinton grid. We tried large solar powered signs, these were found to be quite expensive and had traffic still go past. These have been removed and a cement barricade has been placed on the respective driving lanes with a sign stating Road Closed to Thru Traffic. The Warning signs regarding the ban are placed in the ditch. Crew and I will discuss this on Monday and possibly adjust.

Gregoire Construction is progressing.

The letter was sent August 20th regarding completion standards.

Goodfellow Construction has not began.

Ulmer has not signed the tender agreement, nor produced the performance bond. Options?

Site meet was held with ALH on the Poppleton Road Construction. Dave, Bob, Bernadette, AI, AI Jr. and myself present at 9:00 am Tuesday, September 4, 2018. Discussed problems with Plains Midstream crossing, SaskTel line being moved and hauling/finding clay. Noted the 20:1 slope on north/east side, 50 cm top, removal of trees. ALH seem confident the job can be done to best of their ability and in a timely manner depending on weather.

2019 Construction/Pavement drilling and lab testing are complete. Surfacing design is in process, gravel, crossing agreement checks and environment.

Pavement – 675 North not completed, Lilydale needs more work and Baldwinton Grid not done yet.

Ian has done a lot of work at the Neilburg School track. So far 96 hours were done with the Cat rented from Mr. Flicek, 50 hours with lan's bob cat, many loads of clay from Chibri's, loads done by McIntosh Construction, Manitou Lake's Grader, our loader, backhoe, gravel truck. Hopes of there being good material at track did not happen. Next we will be moving the rest of the hill and tidying site. A decision on what type of gravel to use on the running surface to be discussed. We will proceed with seeding the infield with grass, fixing the elementary parking lot and roadway beside rink. New principal has been notified and happy we are involved with the school.

Contacted schools for bus routes. Informed Living Sky School division about Baldwinton Grid ban.

Incident Report

Metal recycling has been completed at the Transfer Station. New option would be to have a Metal bin instead of making a pile. Supreme Recycling will place the bin and remove for free of. They retain any profits from the recycled metal. Waiting for information from PWM Steel.

Club root inspections have begun in the area. If found, we will need to implement sanitization methods to work in affected fields.

Inquiring with Pheiffer Contracting about grass seeding construction and other areas.

We have been notified that Sask Power will be doing maintenance on the power poles in the slough just off Highway 40 by Stonehouse's.

Checking Lilydale Grid Pavement with Glenn to evaluate whether to fix holes or do shim coat.

Meeting with Barry McConnell, Darren Tyler and Josh Tyler regarding water south of Ecology Pit road, tomorrow.
