# Schedule 'C' Workplace Harassment Policy

- 1. Definition (section 2(1)(I) of the *Occupational Health and Safety Act, 1993*): "Harassment" means any inappropriate conduct, comment, display, action or gesture by a person:
  - (i) that either:
    - (A) is based on race, creed, religion, color, sex, sexual orientation, marital status, family status, disability, physical size or weight, age, nationality, ancestry or place of origin; or
    - (B) subject to subsections (4) and (5), adversely affects the worker's psychological physical well-being and that the person knows or ought reasonably to know would cause a worker to be humiliated or intimidated; and
  - (ii) constitutes a threat to the health or safety of the worker.

# 2. Employer obligation

The Rural Municipality of Hillsdale No. 440, council and its managers and supervisors, will take all complaints of harassment seriously. We are committed to implementing this policy and will ensure that no employee is subjected to harassment at this place of employment.

# 3. Employee's obligation

All employees, including managers and supervisors employed by the Rural Municipality of Hillsdale No. 440, shall refrain from causing or participating in the harassment of another employee, and co-operate with any person investigating harassment complaints.

# 4. Third Party obligations

This policy covers harassment connected to any matter or circumstance arising out of the worker's employment. Ratepayers, customers, clients, contractors or their workers and others invited to the workplace could harass an employee. The Rural Municipality of Hillsdale No. 440 may have limited ability to investigate or control their conduct. However, Rural Municipality of Hillsdale shall take reasonably practicable action to stop or reduce the risk to its workers of being harassed by third parties.

#### 5. Procedure for dealing with harassment concerns

All complaints will be taken seriously. The rights of all concerned will be respected. Employees are encouraged to use these steps to address incidents of alleged harassment internally.

- 5.1 An employee who believes that he or she has been subjected to harassment is encouraged to first clearly and firmly make known to the alleged harasser that the harassment is objectionable and must stop.
- 5.2 Where this cannot be done, or is unsuccessful, the employee should report the alleged harassment to the Administrator. In the event that the complaint is against the Administrator, the worker should report the alleged harassment to the Reeve who will then take the action indicated below for the Administrator.
- 5.3 Once a person designated by the employer receives a report, that person shall immediately bring the complaint to the attention of the employer.
- 5.4 The employer will discuss options to resolve the complaint with the complainant. Where the conflict cannot be promptly resolved in a matter satisfactory to the complainant, the employer will notify the alleged harasser of the complaint; provide the alleged harasser with information concerning the circumstances of the complaint; and undertake a confidential investigation.

- 5.5 Following the conclusion of the investigation, the employer will inform the complainant and the alleged harasser of the results.
- 5.6 Where harassment has been substantiated, the employer will take appropriate corrective action to resolve the complaint.
- 5.7 Where harassment has not been substantiated, no action will be taken against a worker who has made a complaint in good faith.

#### 6. Confidentiality

Rural Municipality of Hillsdale No. 440, will not disclose the identity of the complaint or alleged harasser, except where disclosure is necessary for the purpose of investigating or taking disciplinary action in relation to the complaint, or where such disclosure is required by law.

#### 7. External complaints

Nothing in this policy prevents or discourages an employee from referring a harassment complaint to the Occupational Health and Safety Division or the Saskatchewan Human Rights Commission. An employee also retains the right to exercise any other legal avenues available. # A BYLAW TO AUTHORIZE THE EXPROPRIATION OF LAND

The Council for the Rural Municipality of Hillsdale No. 440 in the Province of Saskatchewan enacts as follows:

- 1. The Council of the Rural Municipality of Hillsdale No. 440 deems it necessary to acquire 0.63 acres in the South East quarter of 17-44-23 W3M, shown as SE 17-44-23-3 Plan AG2288 Ext 0 Parcel Number 147043324, for the purpose of acquiring right of way for the construction of a road diversion due to water on Township 442.05 and cannot do so by agreement with the landowner who is Canadian Pacific Railway Company.
- It shall be lawful for Council of the Rural Municipality of Hillsdale
  No. 440 to expropriate said property; and to proceed in
  accordance with the provisions of *The Municipal Expropriation Act.*
- 3. This bylaw shall come into force and take effect upon the date adopted by Council.

# A BYLAW TO AUTHORIZE THE EXPROPRIATION OF LAND

The Council for the Rural Municipality of Hillsdale No. 440 in the Province of Saskatchewan enacts as follows:

- 1. The Council of the Rural Municipality of Hillsdale No. 440 deems it necessary to acquire 1.84 acres on the West of SW 8-46-24 W3M, shown as Blk/Par B- Plan 101643825 Ext 39, Parcel Number 150288015, for the purpose of acquiring right of way for the construction of a road diversion due to water on Township 442.05 and cannot do so by agreement with the registered land owner who is The Governor and Company of Adventurers of England Trading into Hudson's Bay.
- 2. It shall be lawful for Council of the Rural Municipality of Hillsdale No. 440 to expropriate said property; and to proceed in accordance with the provisions of *The Municipal Expropriation Act*.
- 3. This bylaw shall come into force and take effect upon the date adopted by Council.
