Baldwinton Grid

- Option 1- Constructing the road to grid road standard with a road height that ensures that the road is constructed higher than the natural spill point of the basin.
- Option 2- Constructing the road to grid road standard at 1 ½ the height of Option 1 with easements with the landowners affected to allow for pumping the water over the spill point.
- Option 3- Construct the road to a grid road standard at a new location where the approach to HWY 40 meets current highway standards.

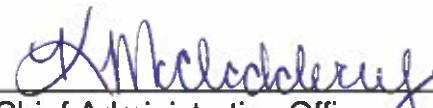
